#### II. [TRAI CIRCULAR / LETTERS / NOTICE](#)

- A. TRAI has issued the 'Telecom Commercial Communications Customer Preference (Fourth Amendment) Regulations, 2010' on 28<sup>th</sup> February 2011. The date of implementation of Telecommunication Commercial Communications Customer Preference Regulation 2010 has been extended to 21st March 2011.
- B. TRAI vide letter No.323-3/2010/CA (Vol.V) dated 23<sup>rd</sup> February 2011 intimated the Association about TRAI organising Regional Workshops on Consumer Education in Telecommunication at Lucknow and Shillong on 10<sup>th</sup> March 2011 & 15<sup>th</sup> March 2011.
- C. TRAI has issued a letter No.409-12/2008-FN(Part-II) dated 22nd February 2011 clarifying their earlier regulation of 9th March 2009, thereby advising service providers to ensure strict compliance of this provision on the basis of complaints received from various service providers on levying termination charges on SMS.  
  
TRAI has also issued similar individual letter in this regard to Bharti Airtel and Idea Cellular.
- D. On 8th February 2011, TRAI has issued a letter to the Secretary, DOT regarding pricing of Spectrum in 1800MHz band. TRAI submitted its recommendations regarding the value of

spectrum in the 1800 MHz along with a copy of the report of the Expert Committee based on which the recommendations have been made.

- E. TRAI vide letter no. 402-16/2010-I&FN dated 3<sup>rd</sup> intimated the association about TRAI holding a seminar on "Next Generation Network- Implementation and Implication" on 28<sup>th</sup> & 29<sup>th</sup> April 2011 at New Delhi.

### V. DOT LETTERS

- A. DOT vide letter no. 16-16/2009-AS-III/Vol. III dated 7<sup>th</sup> February 2011 issued a new directive for allocation of MSC coded based on VLR reporting.
- B. DOT vide letter no. 800-20/2010-VAS dated 3<sup>rd</sup> February 2011, issued a clarification reiterating that Financial Penalty for Violation of Terms and Conditions of License Agreement in Respect of Subscriber Verification Failure Cases

is to be calculated on the basis of slabs prescribed in DoT Circular dated 24.12.2008

- C. DOT vide letter no. 1-34/2006-VI (Part I) dated 2<sup>nd</sup> February 2011 intimated that timeline for re-verification of mobile subscribers has been extended till March 31, 2011.

- D. On 14<sup>th</sup> February 2011, AUSPI submitted its response to TRAI Consultation Paper on "Issues arising out of Provisioning and Pricing of services by mobile service providers – in the context of Delivery of Basic Financial Services using Mobile Phones".
- E. On 11<sup>th</sup> February 2011, AUSPI submitted its response to TRAI on study report by ASSOCHAM on MVAS.
- F. On 7<sup>th</sup> February 2011, AUSPI submitted its response to TRAI Consultation Paper on Issues related to Telecommunications Infrastructure Policy.
- G. On 4<sup>th</sup> February 2011, AUSPI submitted a letter to Hon'ble MOCIT regarding a Press Statement of 29th January 2011 on the Policy in respect of Spectrum Assignment.

AUSPI requested Hon'ble MOCIT that:-

- i. *No payment be required to be made by operators for allocation of contracted spectrum beyond the start up spectrum of 4.4 MHz and upto 6.2 MHz.*
  - ii. *One of our member service providers is not having start up GSM spectrum should be allocated initial 4.4 MHz without any payment.*
  - iii. *CDMA operators should be allocated upto 5 MHz contracted spectrum without any additional payment and eligibility requirements should be same as GSM.*
- H. On 3rd February 2011, AUSPI submitted its response to USOF Concept paper "USO Support for Facilitating Access to Telecommunications Facilities for persons With Disabilities in Rural India".
- I. On 3<sup>rd</sup> February 2011, AUSPI submitted a letter to Wireless Advisor, WPC regarding NFAP. AUSPI submitted its comments on certain additions / revisions made by Drafting Group 3 in some of the IND Foot Notes (IND 54 & IND 75 and New IND XXX).

- J. On 2nd February 2011, AUSPI submitted a letter to Hon'ble MOC&IT seeking clarification on Press Statements made by him on the following:

- i. *No payment is required from existing UAS Licensees and holders of Dual Technology Approvals for allocation of contracted spectrum of 6.2 MHz.*
- ii. *new policy will apply prospectively to those who seek fresh UAS licences. And if the proposal is to apply it retrospectively then it would apply equally to all operators including BSNL and MTNL who entered the market at different points in time starting from 1994 till now.*
