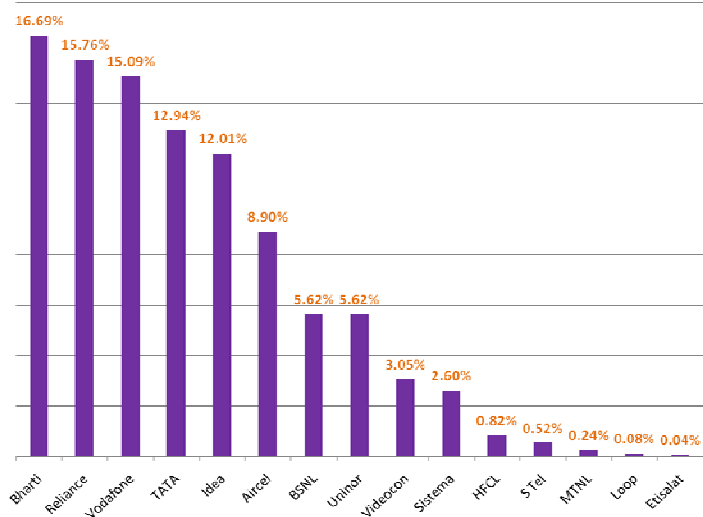

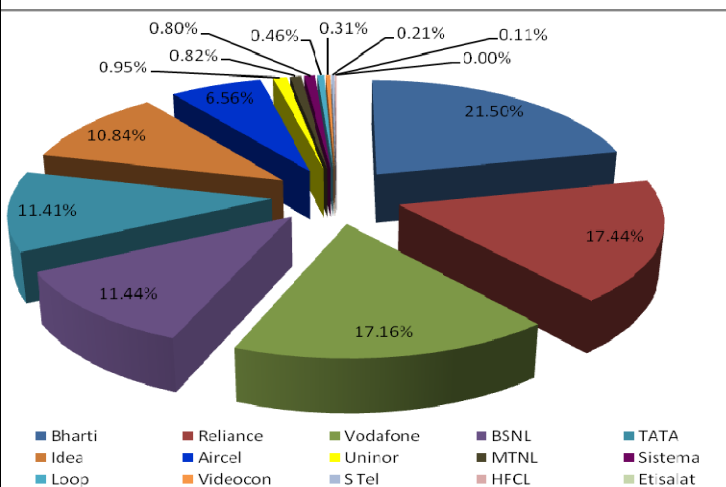
I. SUBSCRIBER FIGURES – JUNE 2010

III. TRAI CIRCULAR / LETTERS / NOTICE

- A. TRAI vide letter no. 323-3/2010-CA dated 26th July 2010 informed the Association about a workshop organized by TRAI on Consumer Education for 2010-11 for the southern zone scheduled on 4th August 2010 from 9.15 a.m at Hotel Nahar Heritage, St. Marks Road, Bangalore.
- B. TRAI vide letter no. 116-7/2009-MN dated 16th July 2010 reminded Industry Associations to submit their views on issues related to NDNC services post implementation of MNP.

IV. DOT LETTERS

- A. On 28th July 2010 DoT issued an Amendment to UASL bearing No.10-15/2009-AS.III/Vol.II/(Pt.)/(25) along with template of the agreement between telecom service provider and the vendors for Security Clearance for import of telecom equipment / software.

- B. In response to AUSPI's suggestion of 26th April 2010 to DOT to create additional column for the complained services for wireless, wireline, wireless internet or wireline internet for online handling of grievance redressal mechanism, PG Cell of DOT replied that they have forwarded our suggestions to NIC for consideration.
- C. DoT vide OM no. 6/29/2009-Policy I dated 22nd July 2010 intimated the Association about constitution of Committee for Laying standards for the M-pin based Mobile Banking POS Device' under the chairmanship of Sr. DDG, TEC. Representatives of the Associations in addition to representatives of UDI, RBI, TRAI, DIT are also Members.
- D. DOT wide letter no. 800-14/2010-VAS-III Vol. II dated 20th July 2010 intimated about extending security safeguards applicable to J&K Service Area to Assam and North East Telecom Circle Area on experimental basis for a period of six months.
- E. DOT vide circular No. 2-1/2007-S (Vol III) dated 19th July 2010 circulated the Minutes of meeting held on 12th July 2010 at DOT on possible solutions for interception & Monitoring of encrypted communications by Security Agencies, chaired by Shri. Ram Narain, DDG (Security).
- F. DOT vide circular No. 17-4/2010-S1 dated 15th July 2010 circulated the Record Notes of discussion of MNP Implementation review meeting held on 9th July 2010 at DOT under the Chairmanship of Member (T).
- G. DOT in response to ACT letter dated 27th March 2010 regarding Multiple Connections in J &K clarified through their letter no. 1-34/2010/S1(Pt.) dated 14th July 2010 that;
 - a. *instructions issued by TERM Cell J&K is in line with DOT's instructions.*
 - b. *connections issued by Service Providers in violation of the DOT instructions will be treated as violation of license conditions.*

- I. DOT issued a press release on 30th June 2010 extending the timeframe for implementing Mobile Number Portability to 31st October 2010

VI. AUSPI LETTERS

- A. On 28th July 2010 AUSPI submitted a letter to Secretary (T), DOT with reference to DOT's guideline of 20th July 2010 extending security safeguards applicable to J&K Service Area to Assam and North East Telecom Circle Area on experimental basis for a period of six months.

AUSPI requested DOT to:

- a. *Allow minimum 3 months time for implementation of new acquisition process in DOT's letter of 20th July, 2010.*

- b. Clarify that re-verification process of prepaid subscribers will be as per the DoT guideline No. 1-3/2006-VI (Pt I) dated 30/9/2009.
- c. 6 months time to complete the activity of re-verification.
- B. On 27th July 2010, AUSPI submitted its Counter comments on stakeholders' response to TRAI Consultation Paper on 'National Broadband Plan'.
- C. On 26th July 2010, AUSPI submitted a letter to Member (T), DOT regarding its recent guideline on Security safeguards for Assam & North East Service areas requesting as follows:-
- a. Clarifications before the service providers start implementing security safeguards for North East and Assam service areas.
- b. two weeks time to implement security safeguards after clarifications of above mentioned issues.
- D. On 26th July 2010, AUSPI submitted a letter to Vice Chairman, National Disaster Management Authority (NDMA) regarding Frequency spots for Public Protection and Disaster Relief. AUSPI requested NDMA to examine and pinpoint the requirement of PPDR amongst the various frequency bands listed in the NFAP of the WPC (DOT) so that other bands could be utilized commercially for mobile services without interference.
- E. On 22nd July 2010, AUSPI submitted a letter to Hon'ble Chief Minister of Maharashtra regarding Show Cause/Demand Notices issued by Municipal Corporations in Maharashtra making exorbitant demands based on circulars/notifications/ orders with respect to mobile towers in Maharashtra.
- AUSPI requested Hon'ble CM amongst other issues, the following:
- a. All orders for imposition of penalties for regularization of towers in Maharashtra may be withdrawn;
- b. All applications for setting up of towers may be examined in a time bound manner and approvals/permissions be granted within pre-specified timeline.
- c. All sealing orders for towers should be immediately withdrawn.
- d. Instructions to local bodies be given to hold a special effort for a one time camp/drive to clear all the current pending approvals to clear the backlog.
- e. immediate direction / instructions may be given to the Municipal Corporations/Councils to immediately stop sealing/demolishing the said Towers and to de-seal / restore the Towers which have already been sealed/ demolished arbitrarily.
- F. On 21st July 2010, AUSPI submitted a letter to Secretary (T), DOT requesting to grant permission to our Member Service Providers for Placement of Purchase Order on the basis of undertaking on urgent basis.
- G. On 21st July 2010, AUSPI submitted a letter to Secretary (T), DOT requesting that Charges for different slots in 7GHz band for backbone should be levied for only one spot of 28MHz (@ 0.15%) in one service area irrespective of the number of slots allocated.
- H. On 20th July 2010, AUSPI submitted its response to TRAI Consultation Paper on National Broadband Plan.
- I. On 15th July 2010, AUSPI submitted a letter to Chairman, TRAI requesting for a consultation process for reviewing the port charges at an early date.
- J. On 15th July 2010, AUSPI submitted its Views / Comments for TRAI's Pre Consultation on Green Telecom

K. On 13th July 2010, AUSPI submitted a letter to Hon'ble Minister of Communications & IT inviting his attention towards PTI article dated 8th July 2010 captioned as 'TRAI report lopsided; no one-time charge for spectrum: Mittal.

AUSPI in its letter stated that ever since the TRAI recommendations on 'Spectrum Management and Licensing Framework' have been issued, the incumbent private GSM operators have launched an offensive attack on the regulator calling the recommendations as retrograde, regressive and lopsided. The onslaught of these operators on TRAI recommendations is primarily due to its recommendations on the pricing of excess 2G spectrum based on market determined price i.e 3G auction price etc.

AUSPI requested Hon'ble MOC&IT that:

- a. *Incumbent GSM Operators who are holding excess spectrum should be asked to pay for it at least as per the recommendations of TRAI. They may be asked to surrender the excess spectrum in case they do not want to pay for the excess spectrum, so that the initial start up spectrum can be given to one of our members.*
- b. *Spectrum charges are payable at the time of renewal of licenses and operators are free to surrender the license in case they do not want to pay for the spectrum.*

L. On 13th July 2010, AUSPI submitted its Suggestions to DOT on 'Strategic Plan & Policy for DOT for next 5 years.

M. On 9th July 2010, AUSPI submitted a letter to Secretary (T), DOT regarding Spectrum Harmonization for CDMA 450 MHz. AUSPI requested DOT's support to get the 450 MHz band vacated and make it available as the growth path for the CDMA operators.

N. On 9th July 2010, AUSPI submitted a letter to the Secretary (Home), MHA regarding Security clearance for Import/placement of purchase order for Procurement of Telecom Equipment/software.

O. On 7th July 2010, AUSPI submitted a letter to Secretary (T), DOT requesting to issue List of Core equipment and clearance for import of equipment allowed on the basis of undertaking given by Service Providers.

P. On 7th July 2010, AUSPI submitted a letter to CMD, BSNL requesting for implementation of TDSAT Judgement on Port Charges Matter.

Q. On 7th July 2010, AUSPI submitted a letter to Secretary (T), DOT regarding a News Paper article about DoT's internal committee recommendations under Chairmanship of Advisor (T) to set up a fund to encourage and bankroll local manufacturing and research into telecom equipment.

AUSPI submitted that:

- a. *Universal Service Obligation Fund cannot be used for creating another fund to encourage and bankroll local manufacturing and research into telecom equipment;*
- b. *License Fee is attributable only to the Universal Service Fund and not to the fund for promoting manufacturing.*
- c. *Existing sources of funding for R&D should be exploited rather than undertake this under the ambit of the USOF.*

R. On 2nd July 2010, AUSPI submitted a letter to Secretary (T), DOT regarding progress on DoT Committee for Evaluating TRAI Recommendations on 'an Approach to Rural Telephony – Suggested Measures for an Accelerated Growth'.

AUSPI requested DOT to intimate the status of the adoption of the various recommendations of the above DoT committee for bringing into force the requisite policy measures proposed in this report which will significantly facilitate the provision of modern facilities and extend the benefits to our rural areas.
