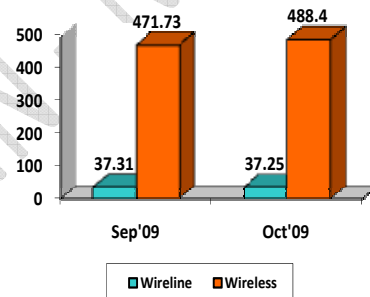

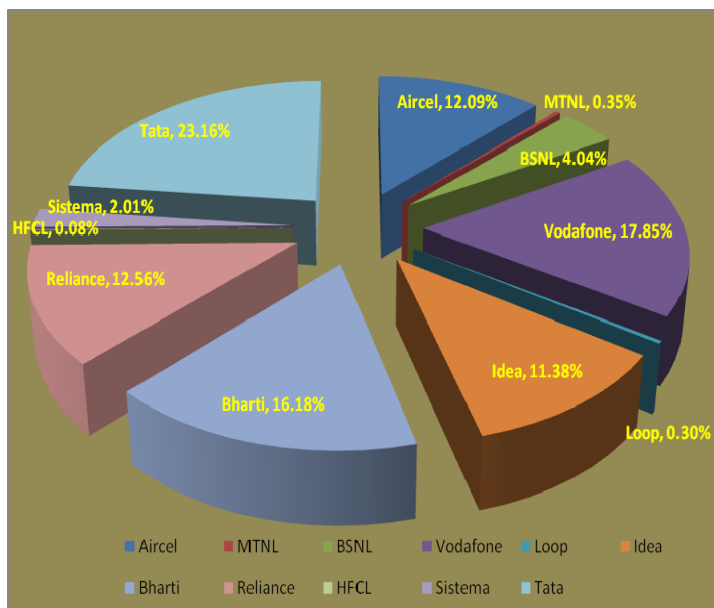

### V. MOBILE NUMBER PORTABILITY.

On November 20, 2009, TRAI issued Telecommunication Mobile Number Portability Per Port Transaction Charge and Dipping Charge Regulations, 2009 (9 of 2009) and the Telecommunication Tariff (Forty-Ninth Amendment) Order, 2009, fixing the various charges for Mobile Number Portability with effective from 31<sup>st</sup> December 2009:

- a. The Per Port Transaction charge shall be Rs.19/-
- b. The Dipping charge is on mutual negotiation between the telecom service providers and the respective MNP service providers.

- c. Porting charge shall not be more than the per port transaction charge i.e. Rs 19/-. The operators are free to charge any amount less than or equal to this charge

- A. 2nd Steering Committee Meeting of India Telecom 2009 was held on 11<sup>th</sup> November 2009 at Committee Room, Sanchar Bhawan, New Delhi.
- B. Auction For 3G and BWA Spectrum - Pre-Bid Conference was held on 16<sup>th</sup> November 2009 at Mantra, The Park New Delhi.

## XII. AUSPI LETTERS

- A. On November 30, 2009 AUSPI submitted a letter to DDG (AS-II) seeking clarification if the Genuine IMEI implant program could continue beyond 30th Nov 09.
- B. On November 27, 2009 AUSPI submitted its suggestions for Budget 2010-11 regarding changes in Direct and Indirect to Jt. Secretary (TRU), Ministry of Finance.
- C. AUSPI Counter Comments on TRAI's Consultation Paper on Overall Spectrum Management and review of license terms and conditions dated 16th October was submitted to TRAI on 19<sup>th</sup> November 2009.
- D. On November 13, 2009 AUSPI submitted Questions for Clarifications on 3G / BW Auctions for pre-bid conference to Secretary (T), DoT.
- E. AUSPI response to TRAI Consultation Paper on Overall Spectrum Management and review of license terms and conditions dated 16th October was submitted to TRAI on 12<sup>th</sup> November 2009.
- F. On November 11, 2009 AUSPI submitted a letter to Secretary (T), DOT requesting

defraying for depositing Bid Amount for Spectrum Auction.

- G. On November 10, 2009, AUSPI submitted a letter to Secretary (T) DoT requesting extension of cutoff date for implanting IMEI on non-genuine handset by three months instead of 30<sup>th</sup> November 2009.
- H. On November 5, 2009, AUSPI submitted a letter to Chairman TRAI on Implementation of Mobile Portability. Through its letter AUSPI requested the Authority to resolve all open issues like Porting Charges, Porting Process, Dispute resolution, Inter-operator Testing Schedule, Process for LEA of ported numbers, Operator codes, Interface specifications, Commercial agreement Connectivity etc to ensure timely implementation of MNP.

Similar letter was also being submitted to Secretary (T).

- I. On November 3, 2009, AUSPI submitted a letter to Secretary (T) DOT on settlement of important policy issues under consideration of Government / TRAI before 3G/BWA Spectrum Auction.

AUSPI requested that the 3G spectrum auction be considered only after the TRAI review of UAS licensing conditions is completed as the current UASL conditions cannot be amended without TRAI recommendations.

- J. On November 3, 2009, AUSPI submitted a list of pending issues which are of utmost importance for the telecom service industry to Hon'ble Minister of Communication & IT for discussion during the meeting called by MOCIT with CEOs of Telecom Companies.

## XIII. JOINT INDUSTRY LETTER

- A. On November 25, 2009, Industry Associations submitted Information on the benefits provided to Rural Subscribers by Member Service Providers to TRAI.

B. On November 18, 2009, Industry Associations submitted a letter to TRAI seeking time till 31<sup>st</sup> January, 2010 from the Authority for implementation of the TRAI's direction on VAS dated 27<sup>th</sup> April and subsequent amendment dated 4<sup>th</sup> Sept. 2009.

C. On November 9, 2009, a Joint Industry Letter was submitted to Hon'ble Minister of Commerce & Industry on Eligibility of Telecom Exports Income for SFIS under the Foreign Trade Policy 2009- 20014 .

Industry Associations requested Hon'ble Minister of Commerce & Industry to review SFIS under Foreign Trade Policy 2009-2014 and reinstate provision of SFIS for Telecom Service Providers which was available under the previous FTP 2004-2009.

D. On November 3, 2009, a Joint Industry Letter was submitted to Secretary (T) on the issue of Imposition of Sales Tax on the telecom services using optical fibre by Government of Karnataka.

## **XIV. ACT LETTER**

A. On November 10, 2009, ACT submitted a letter to DDG (Security) on the list of Authorised documents for subscriber verification.

Through this letter ACT sought clarification from DOT that Documents accepted as valid as per earlier DOT directives will not be termed as invalid and negative in audits by the TERM cells and A bank statement (not older than three months) will be acceptable as proof of address.

ACT also requested DOT to issue clear instructions to the TERM Cells on list of Authorised documents accepted for subscriber verification.

B. On November 10, 2009, ACT submitted a letter to DDG (Security) on Imposition of penalty for violation of terms and conditions of License Agreement in Punjab Service Area, based on the sample verification of subscriber carried out by Additional Director General of Police, Intelligence, Chandigarh.

C. On November 10, 2009, ACT submitted a letter to DDG (Security) on requirement of Photograph of Customers on CAF (Customer Acquisition Forms) for Acquisition between Nov 2001 & May 2005.
